The Ron St Clair MDA Bowl-a-thon is set for 7:00PM Saturday, April 21 at the New Hope Bowl.

MDA is leading the fight to free individuals — and the families who love them — from the harm of Muscular Dystrophy, ALS and other related muscle-debilitating diseases that take away physical strength, independence and life. We use our collective strength to help kids and adults live longer and grow stronger by finding research breakthroughs across diseases; caring for individuals from day one; and empowering families with services and support in hometowns across America

Besides putting big, beaming smiles on the faces of young people with Muscular Dystrophy, the money we collect at the MDA Bowl-a-thon helps;

- 1) Children be able to attend Camp Courage (MDA Summer Camp) near Maple Lake, MN where they can enjoy activities under the watchful eyes of personal camp counselors and on-site medical staff trained in the special needs of children with neuromuscular diseases.

The 26th annual National Association of Letter Carriers' Stamp Out Hunger® Food Drive is on Saturday, May 12

The Letter Carriers' Stamp Out Hunger® Food Drive is the outgrowth of the National Association of Letter Carriers' tradition of community service, a tradition exhibited repeatedly by members of the letter carriers' union over the years.

For many years, a number of NALC's branches (locals) had collected food for the needy as part of their community service efforts.

A national, coordinated effort by the NALC to help fight hunger in America grew out of discussions in 1991 by a number of leaders at the time, including NALC President Vincent R. Sombrotto, AFL-CIO Community Services Director Joseph Velasquez and Postmaster General Anthony Frank. A pilot drive was held in 10 cities in October of 1991, and it proved so successful that work

began immediately on making it a nationwide effort.

A revamped drive was organized for May 15, 1993 — the second Saturday in May — with a goal of having at least one NALC branch in each of the 50 states participating.

The result was astounding: More than 220 union branches collected more than 11 million pounds of food—a one-day record in the United States.

From Alaska to Florida, from Maine to Hawaii, letter carriers did double duty on Food Drive Day—delivering mail and picking

up donations. The Food Drive just grew and grew from that point.

The food drive has surpassed 1.5 billion pound mark in total food collected over its history and will surpass the 2 billion pound mark in the near future.

Exec Vice President's Report

COMMITTEE OF PRESIDENTS

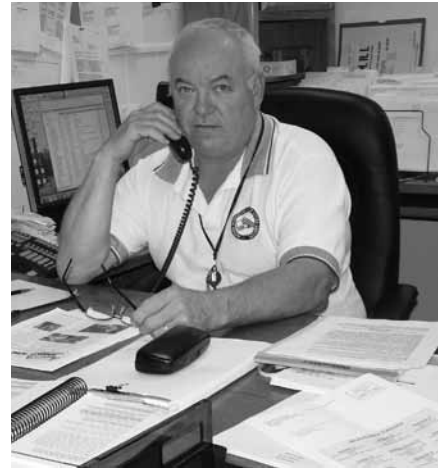
I attended a Committee of Presidents meeting on March 18th and 19th in Jacksonville Fla. This meeting is held twice a year (spring and fall) and are attended by the President (or designee) of all the branches that make up the NALC. Our National President Fred Rolando discussed with us the most current information concerning the union and issues with the Postal Service at the national level.

NATIONAL AGREEMENT

President Rolando updated us with issues still concerning the new contract. There are still about 6000 CCA's having issues where they have not yet received the back pay that was negotiated in the new agreement. Both parties hope to have this issue resolved in the near future but no date has been notified to the union yet. President Rolando also talked about the step increases due in May for CCA's that had prior TE time and foresees a possible problem with that also having issues. There is still some disputes on the agreement concerning the holiday clause for CCA's of when that holiday pay benefit was to begin with the Postal Service claiming it should begin with ratification date and the Union maintaining it begins with the earlier contract date of May 2016. Currently there has been 51,000 CCA's converted to career nationally and NALC is still monitoring the percentage of CCA's nationally as those caps are still in place with this agreement. As I had stated earlier this meeting is attended by presidents from all parts of the nation and while their members are in different states the questions that were asked of President Rolando confirmed that the issues facing our members here in Minneapolis are not confined to just our area. It is the same all over.

LEGISLATION

President Rolando made it very clear that any legislation that comes out of congress that does not address the pre-funding mandate will be very damaging to the workers and the Postal Service. While our retirement funds are currently 100% pre-funded the mandate to pre-fund future retiree health benefits for the next 75 years is crippling the service. This fund is a 100 billion dollar requirement for the Postal Service with 52 billion dollars currently achieved. It is this remaining 48 billion that is currently and will continue to cripple the Postal Service if immediate action is not taken. The NALC has actively been in contact with the Senators and Representatives on both sides of the aisle on postal issues and have been successful in maintaining bipartisan support for 6-day and door to door delivery at this time but this all can quickly change if we do not continue to be active. President Rolando also spoke on the issues in the proposed Federal Budget submitted by the White House and we discussed all the issues that will affect all of our federal benefits that we have successfully achieved in past National Agreements whether through arbitration or negotiations. With all the issues that were discussed by the attending branch presidents President Rolando emphasized that while we do have workroom floor issues and they will be addressed we have far more to lose in the political arena if we are not engaged and diligent and strive to retain our rights and benefits. Currently nationally there are only 8% of our members that contribute to Letter Carrier Political Fund (LCPF) and it takes money to get into legislator's offices to be heard. Mike and I (during every meeting) encourage

and urge our members to contribute \$5.00 a pay period to the political fund and we will continue to do so as this is the only way we are going to be successful in protecting our benefits into the future.

BOARD OF GOVERNORS

The Board of Governors is made up of 9 appointed members, the Postmaster General and the Assistant Postmaster General. Currently there are 0 (zero) Governors on the board. It is a 7 year term with only 5 that can be from one political party and 4 have to have business experience of running companies with at least 40,000 employees. These positions are filled by friendships and favors from the administration in office at the time. The NALC has provided names for possible consideration from both parties for the Administration and Congress to decide on. President Rolando was very clear that the future Board of Governors consist of businessmen and businesswomen with the agenda of growing (not reducing) the Postal Service. That is what the forefathers of this country insisted on when Postal Service was first established, that every citizen had the right to an informational delivery system available for all to use.

- 2) Support group sessions to educate and allow parents the time to network with others having like experiences raising children with neuromuscular diseases.
- 3) Physical therapy for those with neuromuscular diseases.
- 4) Repair wheelchairs and other equipment designed specifically to help children and adults with neuromuscular diseases.
- 5) Research to cure neuromuscular diseases.

Fighting Muscle Disease

2018 MDA MINNESOTA STATE AMBASSADOR



Abby Loch, a happy, loving 11 year-old from Apple Valley, MN has been selected as the 2018 Minnesota State Ambassador for the Muscular Dystrophy Association.

She was diagnosed as a Manifesting Carrier of Duchenne Muscular Dystrophy at the age of 9. Duchenne Muscular Dystrophy is one of the muscle diseases covered by MDA's research and care programs.

Duchenne Muscular Dystrophy can affect the muscles of the hips, pelvic area, thighs and shoulders, and later the skeletal (voluntary) muscles in the arms, legs and trunk. The calves often are enlarged. By the early teens, the heart and respiratory muscles also are affected. The disease primarily affects boys, but in rare cases it can affect girls.

Her nickname is Happy Abby! Abby loves to attend MDA Summer Camp. As the new State Ambassador, Abby will make public appearances throughout the state, representing kids and adults with muscular dystrophy, ALS and related life-threatening diseases that severely weaken muscle strength and mobility in Minnesota.

DELIVERY AND PAY ISSUES

Executive Vice President Brian Renfroe spoke of meetings with the Postal Service on a possible joint route adjustment process and stated the talks have gone poorly with no commitment from management. Part of the problem Brian stated was the fact that management's panel in the discussions are all new and were not part of the group that took part in the previously agreed upon processes and are not willing to commit to anything where management is not in total control of. Brian and the attendees spent a lot of time discussing the issue of time card fraud and where in parts of the country supervisors and postmasters were altering and sometimes deleting time card rings to make it appear the carriers were not on the clock later than upper management wants them to be. There are investigations currently being conducted in several cities with major violations being discovered. Brian urged us to inform all our members to

monitor their hours worked and report any issues immediately to the branch offices. The NALC website is working on having a program soon where a carrier can track their daily work hours and know exactly how many hours they have worked and able to confirm on the next paycheck if there is any possible improper adjustments.

There were about 257 officers and presidents of branches from all over the country attending and when one brought up the issue of mail not being delivered President Rolando and Brian asked how many branches had this issue occurring and almost all of the attendees hands went up much to the astonishment of the national officers. They did not realize this was an issue and let us know that Postmaster Brennan is not aware of this either. We were instructed to report daily any of these non-delivery issues. So for all the members of Branch 9 if you become aware of mail that is cased and taken to the street and then not delivered because a carrier

has been instructed to suspend delivery and bring the mail back please get in contact with Mike or I.

CITY DELIVERY

Director of City Delivery Chris Jackson updated us on the proposed new vehicles the service is attempting to purchase. There are currently 5 prototypes being tested at the postal test site and they are being driven 30,000 miles with every aspect of delivery being tested. At the end of this testing they will be sent to different areas of the country to also be used in a test phase and that is to happen shortly. The trucks are pictured on the website trucks.com for our members to see. At this time it is projected that the new vehicles will be delivered to the Postal Service in early 2020.

Chris also informed us that there is an updated process being rolled out for the CCA Carrier Academy and also a new CCA Resource Booklet to have all the current information and issues answered for our new employees.

Above and Beyond the Call of Duty



Chad Steinke, a carrier from Lake Street Station, received the Branch 9 "Above and Beyond the Call of Duty Award" at the March GMM for his efforts in being the eyes of the community in which he works. He truly has made a difference.

While delivering his route on a bitterly cold day Chad noticed someone lying face down on a concrete landing near one of his buildings. As he got closer, he recognized that she was one of his patrons who has Parkinson's Disease. While he was trying to assist her, she told him that she had fallen and could not get up and thought she had been lying there for about an hour. Chad asked someone from across the street to call 911 while he stayed with the elderly woman. He helped her sit up, gave her his coat and hat and tried to get/keep her warm until the paramedics arrived.

The elderly woman then thanked Chad and said "You saved my life".

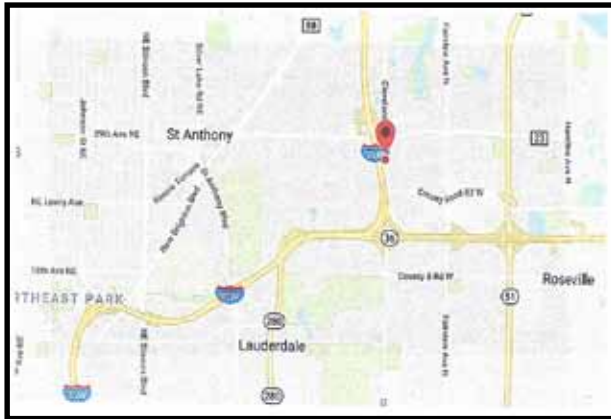
