# Imagine.....

Try to envision coming in to work after our bargaining rights are taken away. Everything that is in the contract, no longer applies. You clock in, walk over to "your" route, the supervisor approaches you and tells you to work on the aux route today. You begin to argue that you aren't on the overtime list... but wait; there is no overtime list! "Your" route doesn't exist anymore either. You have to carry what you are told to carry and the supervisor doesn't like it when you argue, so you have to carry the aux route and the heavy business route. "That will take more than 12 hours" you say. Well the 12/60 rule no longer exists either. You think "gosh I am glad my vacation is coming up soon", but wait; you can't take your vacation because the station is understaffed. You will have to wait until management thinks they can spare you to take that hard earned leave time. Oh that's right, the amount of leave we get is also bargained for. You don't have sick leave anymore, you have to use your vacation time when your kids get sick so there will be no vacation this year.

These are some of the things we as carriers take for granted, that our union leaders sat down and bargained for. The public employees in Wisconsin are facing the loss of their right to collectively bargain for benefits, and wages. We can lose our rights if this is allowed to snowball.

It's time to start paying attention to the candidates we elect to office. Governor Walker never mentioned (during his campaign) his intent to take this right away from public employees, but he did have a history of doing just that. One of the speakers at the rally we attended in Madison said that 39% of union households in Wisconsin voted for Governor Walker! They ended up voting for a pay cut, and more importantly, the loss of their right to be represented at the bargaining table.

This fight is a big one and there is a lot of misinformation out there. One thing that is commonly reported is



that our union dues are being used to elect Democrats. This is not true, and it is the reason why giving to COLCPE and PAL9 is so important. The union is not allowed to use our dues for politics. COLCPE and PAL9 are our political action funds, used to educate and to help candidates that are labor friendly get elected. It is the choice of each union member to decide if they would like to donate, a choice we all should be considering if we want to keep our contract and our bargaining rights.

# **Executive Vice President's** Report

#### Help Wanted

If you watch the news pundits, they are reporting that the economy is starting to turn around. One of the indicators that they are using is that industry is planning on hiring in the near future. Does that mean that we will be seeing "help wanted" signs in the window? What kind of jobs will people be hired for? Will they be good middle class jobs that working men and women can raise their families on? There is a "help wanted" sign out there; it's just not talked about very much. The sign speaks of a need for representatives for working people. Did you know that the word representative comes from an old French word that means those who were "standing for others." We need this e type of representative that we need today. We need people who are willing to stand up for others. This is not the job for a few. We need everyone to become a representative for letter carriers and more importantly to represent themselves for who and what we are, working men and women.

So what is a letter carrier representative? All too often we limit what we consider as representatives to elected officers and stewards. There are a lot of ways to be a representative of letter carriers. In the last issue of the Branch Nine News there were pictures from the rally in Madison, WI. Branch 9 members were representing or standing for others that Sunday morning. They were supporting teachers and public employees who are under attack by those who would make these people the scapegoat for the current economic climate in Wisconsin. A week later there were more Branch 9 representatives standing on a bridge deck in Hudson, again in support of the workers in

Wisconsin who were simply trying to keep the right to collective bargaining from being taken away. These are just two examples of the job of a Branch 9 Representative. Here are some more:

**Help wanted** - Shop Steward. Currently there are several offices that do not have the proper number of designated stewards or alternate stewards. The job description of a steward is to be responsible for investigating and filing grievances for contractual violations and disciplinary action against the carriers in their work unit. They are expected to attend the training sessions sponsored by the Branch, make announcements and post information, and to help new and probationary employees learn station policies ... These are the duties of the steward from the Branch 9 By-Laws, but to be honest, they should be in the job description of every Branch 9 member. A steward is someone who has to be willing to stand up for others including themselves when their contractual rights are at stake. To some, the job of a steward may seem daunting and time consuming. It is. There is support for those who choose to stand for others by way of training and additional help. But the steward also needs the support of those around him or her on the workroom floor. The ability of the steward's and the alternate's to do their job well can best be determined by those who are being represented. The old saying is true many hands do make light work. The same is true of the job of the steward and the alternate if the rest of the unit is involved.

Help wanted – Political Coordinators, Legislative Volunteers and contributors to COLCPE and PAL9. The February Postal Record



and the Branch Nine News have listed those who have contributed to COLCPE and PAL9. To those of you who contributed or volunteered on behalf of the Branch in the political arena, Thank You. As a contributor and/or volunteer, you are a representative of our legislative efforts on behalf of letter carriers and working men and women. Your contribution to the "Gimme 5 campaign" and members of PAL9 provide the resources to get our message to state and federal elected representatives. If you look around the country the coordinated attacks on working people especially those in unions, we need more people to be representatives of letter carriers and working people, to be willing to be standing for others in the legislative arena. To be willing to stand for others as we did in Wisconsin and for ourselves. There are plenty of openings.

**Help wanted** – Safety Liaisons. There is a signed agreement between the President of Branch 9 and the Postmaster establishing Station Safety Liaisons. These are volunteers who have committed themselves to trying to make a safer work environment for letter carriers. They do this by inspecting our facilities looking for safety hazards. They also investigate every accident to try and determine its cause. This is

Sequence System (FSS) machines the office time of carriers will be impacted. Management, I am sure has the projected hours all figured out for what the savings are going to be, and any carrier that has been around the Post Office for more than 5 years knows that the total hours projected by Management is usually not achieved. # FOOD DRIVE 2011

May 14, 2011 will mark the 19th Annual NALC Food Drive, the largest one day food drive in the nation. Last year in Minneapolis we raised 764,000 pounds of food in one day, this was a new record. This year the need for food assistance is as great as ever Our economy is still struggling to recover from the "great recession", and many families in our neighborhoods are struggling to feed themselves. Many of these families are working people with jobs; however some have suffered severe pay cuts, or the loss of a good paying job. The sad reality is a new description of the hungry in America, "Food Insecure".

Insecure households struggle daily with not knowing how to feed their families. Many times Food Insecure families have to choose between eating and paying the bills. In fact

the statistics on hunger in America are startling; of all the hungry in America 1 in 4 is a child. This hungry child could be the neighbor down the street, or a relative. With the end of the winter months and the holiday seasons, donations to local food shelves begin to dwindle. This is why it is so important that we take one\_day of our time to help our neighbors, friends, and family in our community.

During the week of the food drive we will be promoting our event on the radio and television. We will also be participating in the May Day Parade on May 1<sup>st</sup>, "The Heart of the Beast", and we need volunteers to join us. There will be a cook out prior to the parade at 11:30 a.m. The parade begins at 1:00 p.m. and we will walk through the route promoting the Stamp Out Hunger Food Drive, and having fun.

Every station has a food drive coordinator, and if your station does not have a coordinator than your station steward will be the coordinator. As in previous years we are targeting the Tuesday before the drive (May 10) as the day to deliver the Stamp Out Hunger Postcards. We are also targeting Thursday before the drive (May12) we will be delivering the plastic Cub Foods bags to our customers. We pick up all of the food on May 14<sup>th</sup>.

There will be many Cub Foods store locations that will have trucks in the parking lot for carriers to drop off the food donations throughout the day. We are asking that all carriers with a Cub Foods Food Drive Drop Off Site to use that location. Using the Cub Foods sites helps alleviate many trucking issues, and helps keep as many Post Office docks as clear as possible. The food needs to be out the stations by the of the day. We will have a handful of wonderful truck drivers from the Main Office driving around and collecting the food from the stations on May 14th. The station coordinators will have a

truck schedule by the April General Membership meeting.

Every year it takes some special people to pull the whole food drive together. Bob Baird from the Main Office is helping with the food drive working on the logistics part. I think he has been a part of the food drive longer than I have been in the Post Office.

New to the food drive this year is Cathy Burton (Lake Street). She is learning the ropes, and has become a wonderful addition to the team. She is a Co-Coordinator with me, and another contact for food drive questions.

The food drive wouldn't be a success without the help of our local food drive partners, WCCO Radio, Second Harvest Heartland, MTSA Trucking, Cub Foods, and the newest supporters the Rural Letter Carriers.

If anyone would like to volunteer to help out with the food drive please give Samantha Hartwig (Eastside), or Cathy Burton (Lake Street) a call. Messages can also be left for us at the Branch Office.

We are looking forward to another wonderful and successful year for the Stamp Out Hunger Food Drive. Our goal this year for Minneapolis and St. Paul is to raise 1.3 million pounds of food in one day, last year we raised 1.2 million pounds of food. Be safe and have fun.

## High School Seniors: Submit scholarship applications to Branch 9 by May 24, 2010

Every spring, Branch 9 awards three scholarships to graduating seniors: the J. Wesley Woods Scholarship (\$1,000); the Jerome J. Keating/Austin B. Carlson Scholarship (\$2,000); and the Walter E. Couillard/Eugene P. McNulty Scholarship (\$2,000). The awards have made it easier for many students to begin their post-secondary education while honoring the sacrifices and contribuiton of important Branch 9 Leaders.

The following rules apply to all three scholarships:

- A. Any senior graduating from high school and is a dependent of a Branch 9 member is eligible for these scholarships.
- B. The scholarships may be used for any accredited trade school, vocational/technical institute, community college, or university.
- C. Three names will be drawn for each scholarship. The first name picked will be the winner, then first and second runner-up respectively. The winners of any drawing will not be eligible for the other drawing.
- D. The application for the drawings will run in the March and April issues of the Branch Nine News. The drawing will be held at the May General Membership Meeting. The applications shall contain the following information:
- 1. The applicant's name, address, and home phone number.
- 2. The name of the applicant's parent or guardian who is a member of Branch 9.
- 3. The intended school of choice, if known.
- E. Payment to the winners will be made after they have enrolled and can show proof of payment towards their tuition.

Members with dependents who graduate from high school this spring and who plan to attend an accredited education institution next fall, should complete the applications and return them to the Branch Office by May 24 or bring them to that night's meeting. All three forms should be submitted as there are three separate drawings for each scholarship.

Thank you to those of you who are serving as Station Liaisons, but there are still openings in some locations.

As time passes there continue to be changes in who is a representative of Branch 9 and in what capacity. ## Bylaw Submission #2

Proposed Bylaw Change.

In the event the office of Branch President is vacated, the Executive Vice President will fill the position of Branch President for a period not to exceed the first 100 days following the vacancy as "Acting Branch President"

As "Acting Branch President" he/ she will convene a special election for Branch President that shall be held by referendum vote, following the procedures outlined in Articles VI.C and VI.D.

The "Acting Branch president shall appoint election judges and tellers, as needed to oversee this election, under authority of Article III Sec13and 14 of the Branch 9 Bylaws.

The special election for President will be completed within the first 100 days after the office of President has been Vacated. The "Acting Branch President" will resume their position of Executive Vice President upon the outcome of this Special Election.

Nothing in this section would prohibit the "Acting Branch President" from running for the position of Branch President in The Special Election
