### The "Lenny A Larson" Building

At a recent General Membership meeting, the members overwhelmingly voted to name our new building the "Lenny A Larson Building". (Our previous building at 2408 Central Ave was named the same.) During discussion on the recent motion, it was brought up that many newer carriers may not know brother Larson. Let me help with that. (pictured to the right, front row center)

Lenny's tenure as a fulltime officer began some 40 years ago. He served as Branch 9 president for nearly 20 years- itself an extraordinary accomplishment. Issues during these years included fighting off a failed unionmanagement process "Employee Involvement", automation of the letter carrier's work, staffing shortages, the aftermath of 9/11 and ensuring letter carrier safety as anthrax was weaponized in the postal system, and subcontracting letter carrier work as a whole.

Lenny just didn't guide the branch through challenges, though. He seized every opportunity to also build carrier morale and solidarity,

# **PRESIDENT'S REPORT**

At the April General Membership Meeting (GMM) I announced that I will be working on a detail for NALC headquarters assisting with the Regional Workers' Compensation Assistant (RWCA) job for regions 3, 5, and 7 in the month May and all of June. The previous RWCA for Regions 3, 5, and 7, Larrissa Parde, has been prompted to the job of Regional Administrative Assistant (RAA) for Region 5 which has left a vacancy in the RWCA position since January of this year. NALC National President, Fred Rolando, officially offered me the RWCA job and I have accepted the position, which will be effective on July 11, 2022.

This means that in accordance with the NALC Constitution and the Branch 9 by-laws Executive Vice President JoAnn Gilbaugh will become the new Branch 9 President. JoAnn will then need to appoint a new Executive Vice President and they will finish out this term of office till the next Branch election in November of 2024. I wish JoAnn and the Executive Board of Branch 9 the best and know they will continue to represent this membership.

As my term as your President officially ends in July the by-laws call for an end of term report. The biggest change since my December 2021 end of term report has been the purchase of the new Branch office and the sale of property at 2408 Central Ave in Northeast Minneapolis, which has ultimately allowed the Branch Nine Building Corporation to be finically solid for many years to come. Grievances continue to move through different steps of the grievance procedure. There are several overtime violation grievances pending arbitration at this time. When those grievances are resolved through either pre-arbitration or arbitration the Branch will inform the membership of those outcomes.

I have been honored to be your President, and before that your Executive Vice President. In my time as a full-time officer for Branch 9 I have enjoyed getting to know the membership and helping many of you throughout the years. There have also been many previous full-time officers that I have been privileged to learn from; President Emeritus Lenny Larson, along with former Presidents Jan Wild, Pam Donato, and Mike Zagaros. There are many active members that I have also learned much from, but there are too many of you to mention, so I will say, thank you, to everyone. The wonderful thing I have

# **Exec. Vice President's Report**

Congratulations to Sam on her national appointment to Regional Workers Compensation Assistant for Regions 3, 5 & 7. I know she will experience great success in this new endeavor! I am proud of all we have been through and accomplished in the past two and a half years, and I cannot imagine having gone through any of it with anyone else.

Moving forward as your Branch 9 President, I am excited about new directions and that things are looking up. By the end of July, all CCA's in the Minneapolis Installation will be converted to either regular or PTF. All new hires in Minneapolis after this conversion will be PTF's, with instant career carrier status. Hopefully, this will be a meaningful start of a solution to our staffing issues. Positive changes like this have been a longtime coming. Let's hope it is a pre-curser to a similar move for the Associate Offices.

By now you have most likely heard that there is also a new route adjustment agreement from the National Parties. The adjustments will be done by teams who are starting to receive specialized training as we speak. This new program is unique in that each of your routes will be adjusted using your actual performance on your route. No more being followed around by someone you don't know, who doesn't know your route or routine. No more being subjected to route inspectors whose only goal is to make a name for themselves by cutting routes.

We are working on some new initiatives. I am appointing a group of six carriers who are tasked with looking at our staffing issues and producing viable suggestions/solutions. Our History Committee had their first meeting and have started compiling items for our history display. Anyone who has items to donate, please call the branch office to set up a time to stop by.

Lastly, we have a growing number of carriers who have English as a second language. Our work is hard enough – can you imagine trying to do it when you cannot understand most of what is communicated throughout the day? We need to break down these language and communication barriers. How can we do this? By recruiting current members who would be willing to help us translate information and answer questions from new carriers. We are actively seeking anyone who would like to help or has ideas to help our English as a second language carriers.

By my stepping into the position of President, the position of EVP needs to be filled. I am very pleased to announce that I will be appointing Scott Bultena as the next Branch 9 Executive Vice President, upon my move to the position of President. Scott has most recently represented branch members as a Trustee, Lead Formal Step A Representative and **Technical Assistant in Arbitration** Hearings. He has been a Letter Carrier for 17 years and served as Steward at St. Louis Park Station. In addition to the day-to-day administration of the Formal Step A grievance process, Scott's work has been pivotal to our success with both Forced Overtime and JSVB/Dignity and Respect in the Workplace grievances. Scott's temperament and level-headed decision-making skills will serve us all well.

While there are two full-time officers, we could not run the branch without the dedicated



work of everyone on the Executive Board. We are blessed with a talented group, who never miss a beat and are always up to the challenge. Scott moving to EVP leaves a Trustee spot open. A decision on who will fill the position will be made soon.

One last congratulations is in order before I sign off on this month's article. Congratulations to Lenny Larson on the motion to name our new Branch 9 home after him! Lenny was the Branch President when I started nearly 22 years ago. So much of what we have gained as a branch today is due to hard work and ingenuity of Lenny and his cohorts. ### THE ROOTS OF JUNETEENTH

Juneteenth, the nation's newest federal holiday, is the oldest nationally celebrated commemoration of the end of slavery in the United States.

It is rooted in events that took place in Texas in 1865.

President Abraham Lincoln had declared enslaved persons free as of Jan. 1, 1863, but enforcement of his Emancipation Proclamation relied heavily on the power and presence of the Union army. However, Texas, the westernmost state in the Confederacy, did not have any major battles during the Civil War and Union troops did not have a strong presence there. The resulting vacuum allowed slavery to continue for years after the proclamation.

On June 19, 1865, 2,000 federal troops finally arrived in Galveston Bay and declared enslaved persons free by executive decree. In 1866, the first celebration of Juneteenth was held in Texas. What began as church picnics and prayer meetings grew into barbecues, speeches and festivals.

The holiday's celebrants brought "Juneteenth" — a blend of "June" and "nineteenth" — to other states as they moved throughout the nation. Texas made Juneteenth a state holiday in 1980, and most states followed suit in subsequent years.

In 2021, President Joe Biden signed the law establishing Juneteenth as a federal holiday. Because June 19 falls on a Sunday in 2022, the holiday will be observed on Monday, June 20. This year will mark the Postal Service's first observance of Juneteenth.

Juneteenth provides Americans of all races an occasion to both celebrate human freedom and to reflect on the painful legacy of slavery in our country. It also provides an opportunity to re-commit ourselves to the work of achieving true equality for all Americans.

### Now that Open Season for Health

**Benefits is long past**- how can you change your health, dental and vision plans?

There are options to change your health, dental and vision plans. Only if a qualifying life event occurs. So, what is a qualifying life event? A qualifying life event (QLE) is a term defined by the Office of Personal Management (OPM) to describe events deemed acceptable by the IRS that may allow participants in health, dental and vision plans to change their plans outside of open season.

What are some of the qualifying life events (QLE)? They are divided in to three categories: me/my family, job and retirement.

\* Me/my family would include- if I've acquired a new family member, my child's status is changing, a family member died or I'm getting married or remarried. I'm separated or I'm getting a divorce. I'm moving and/or working for another federal agency. If I die and if I've gained or lost coverage under my spouse.

\* My job-my employment status is changing (not retiring). I'm called up to/return from military duty, I'm on leave without pay, I'm in receipt of workers

compensation or I'm leaving federal service (not retiring).

\* Retirement- I'm thinking about retiring, I'm turning 65 years old, I'm retiring on disability and I'm returning as a reemployed annuitant in the federal government.

Also, if you are converted to a PTF or converted to a career carrier you can sign up for health, dental or vision benefits with 60 days.

With all these situations available outside of open season for a qualifying life event to happen-this is a good option to make some changes. All this information is available with greater detail on the OPM.gov website. If you know you qualify and want to make changes call Shared Services. 1-877-477-3273. The site revisions have received mixed reviews, especially on user ease, which could be just an adjustment period. But a Virtual Assistant has been added for 24/7 service and a live online assistant during business hours. Additionally, a mobile application is available and for some documents an e-signature will be allowed. Finally, there is a change in processing

schedule will not affect those who normally get their TSP payments between the 1st and 15th of the month; they will get their payment on the normal date. However, any payments that are scheduled to be made between the 16th and the 31st will be made on the 16th.

But no, I was wrong. So, if you are a retiree now who worked during the time of covid, you are eligible to apply for the Hero Pay. You must apply before July 22nd at frontlinepay.mn.gov.

Also under Lenny's leadership, the branch went through 3 office moves, ultimately buying our very first building on Central Ave. We paid cash in full, in large part because of his focused plan of fiscal responsibility and good investments of branch savings.

Now, Lenny would be the first to tell you that he didn't do any of this- not alone. He would heap praise on his Executive Board and shop stewards, help from other Labor and community organizations, NALC Regional and National Headquarters and especially, the rank and file members of our branch. Lenny was and is the consummate bridge builder, communicator and morale booster. But mostly, he's a fierce advocate for letter carriers and the US Postal Service's mission of public service. He loved to discuss and debate issues, with passion and respect. It may have gotten loud and was likely animated. But whether you ultimately agreed or not, it was sure to end with a friendly meal, a drink and a few stories (as Lenny famously loves to share). That's because Lenny believed everyone had value and a perspective that mattered.

And though Lenny officially retired in 2006, he has continued to work tirelessly for our branch in many ways. He has led committees, mentored young advocates, served on a new building search committee and was responsible for reconstructing our Building Corporation By Laws- an important legal requirement before we could buy a new branch building.

It's also important to know that Lenny is a decorated combat Vietnam War veteran. And he raised three amazing children as a single parent.

Buildings and parks and roadways are named after important people for good reasons. It's a way to bestow an honor on them in a physical form. And we hope when people (who may not otherwise know) ask "who is Lenny A Larson and why is our branch building named after him?" they'll learn about him, and the timeless attributes of a great leader and greater man- and President Emeritus of Branch 9 of the NALC.
