

Remembering the Day the Mail Stopped

At 12:01 a.m. on March 18, 1970, a courageous band of letter carriers in New York City launched what is now called the Great Postal Strike. On its 48th anniversary, the NALC remembers their actions and the legacy it left.

It's important to put the strike in its context. Postal workers had suffered a 50-year losing streak beginning with World War I. Pay scales were frozen, then cut back, and even the "happy days" of the 1950s passed them by as President Eisenhower vetoed four postal salary bills.

By 1967, things were so bad that post office job turnover was around 25 percent a year. Under the gun from their bosses, local managers became increasingly authoritarian and letter carriers became increasingly exasperated and tired of being bullied and denied a living wage.

The National Association of Letter Carriers was caught between a political rock and a legal hard place—a political establishment unwilling to deliver good wages, a decent workplace, and there was a legal ban on strikes by government employees.



At the stroke of midnight, members of Branch 36 began throwing up picket lines around post offices throughout Manhattan and the Bronx. Within hours, other branches joined in and the wildcat strike spread across the land. There is much more to this story, as told in the NALC history, Carriers in a Common Cause, but the key result was the adoption of the Postal Reorganization Act of 1970, which created the U.S. Postal Service. The act gave postal unions the power to bargain for wages and benefits, and the ability to arbitrate contract disputes and enforce members' rights.

As bargaining begins on a new national agreement, we take a moment to say **THANK YOU** to the men and women who put their jobs on the line to protect themselves and the carriers who have followed in their footsteps.

PRESIDENT'S REPORT

Our current staffing and resulting work conditions are unacceptable and have been getting increasingly worse for the past three years. Contrary to Management's belief, this is unsustainable. Carriers are both emotionally and physically exhausted. More and more, this exhaustion is so extreme, they are forced to obtain workhour restrictions in order to function and carry on.

Rather than face the fact that they have failed at staffing, Management has returned to an old familiar narrative; it is the carriers' fault. They reason that if there weren't so many carriers on restrictions, the problem of open routes and untimely delivery would be solved. This stance is nonsensical. At the last count that we were given, we are at least 140 people short of our allowed complement of PTF's in Minneapolis. Those PTF's we do have are being converted to regular faster than new carriers can be hired.

Along with this blame game, Management also lays an expectation that we have a shared responsibility to bring in new hires. While it is proven that referrals have a better retention rate, it is a hard sell. This is a great job and career when things are good, but it hasn't been good for a long time. With no end in sight, it is difficult to encourage someone to apply for the job. Then again, if we don't lead the way, who will? Management hasn't been able to figure it out. Our Branch Staffing committee is back at work, looking for solutions to make a difference locally, to the extent possible.

Just as Management lays the delivery and staffing issues at the carriers feet, a growing number of carriers blame "the union", insisting that we have the ability to fix things, but just don't care to or want to. The frustration that everyone feels is genuine, and the answers are not always what carriers want to hear. At our station visits, the problems and anger that are voiced are real. Everyone wants to know what the union is doing about it.

We want to make sure that everyone is heard, so we have planned a Rap Session with our National Business Agent, Patrick Johnson. It is going to be held at the Crystal VFW, 5222 Bass Lake Road, Thursday, March 23rd at 7:00 p.m. In addition to speaking about our current work environment, Patrick will field your questions. This is your meeting. It will provide the opportunity to explain what is happening daily in our craft. You will be able to ask the hard questions, have the ability to give suggestions for improvement and gain knowledge of what is being done on the Union's side to make things better. Please plan to join us for this important meeting.

Getting Postal Reform passed was huge for the health and welfare of the postal service. But besides making our employer more stable and viable, what was in it for us? It's too soon for us to see any positive trickle down that affects our daily plight. Now that we have jumped that hurdle, it's time to focus on the employees. Our contract talks started last month at the National Level. A major discussion and negotiating priority for the NALC is staffing. There is a video and transcript of National President Brian Renfroe's contract negotiation opening statement on the NALC.org website.

A motion was passed at the February GMM to have a press conference and rally in front of the Minneapolis Main Post Office on Sunday, April 2nd. It is being billed as "Safety, Staffing and Service – Letter Carriers Need a Raise". Other unions, the media and politicians are being invited to attend, along with all of you, of course! The purpose is to inform and gain support from the public, and to influence the current contract negotiations in D.C. We hope

that you will consider taking the time to join us. More information will be forthcoming at the next General Membership Meeting, and through flyers, emails, etc.

To be perfectly clear, this is a rally. It is not a strike or endorsement of a work stoppage or slow-down, which are all fire-able offenses, not to mention against Federal Law. I say this, because we have been informed that carriers have been encouraged or told by some that those scheduled on Sundays do not have to report to work if they are also scheduled on their day off. Or, they do not have to report to work on Sunday because it is a NS day. Carriers are being told there will be no consequence of not showing up to work when scheduled. This is not true. When you are scheduled to work on a Sunday, it is expected that you will report to work. It's safe to say at least 9 out of 10 carriers don't want to work on Sunday, but, as with other situations or contract violations, the rule is obey first, grieve after. It's not ideal, but it can save you from discipline.

We haven't experienced hardships like this for decades. In fact, we haven't experienced anything like this in a large part of our carrier's lifetimes. We need to continue to stick together, do our best to support each other and not tear each other down. That is what a union is about – solidarity through both good and bad times. In Solidarity, Jo To not only survive, <u>BUT TO PROSPER</u>, we must keep the lines of communication open, share ideas, concerns and information.

Exec. Vice President's Report

We are living through unprecedented times. Never has the Letter Carrier craft been so ridiculously understaffed. Everyone is working excessive hours and coupled with the harsh winter that we have had, there is no better way to say it than life for letter carriers is extremely tough right now.

Many carriers have been physically and mentally injured because of the excessive hours and harsh winter weather. So where do you turn for relief when you are hurting? We cannot expect management to lighten our load for us to properly heal so we have been turning to the medical community for help. There are hundreds of carriers on work restrictions right now in the Minneapolis installation and our associate offices.

Recently management has been requiring carriers to provide updated medical restrictions. Management has a right to do this, but their requests need to be reasonable. If a carrier has a long-term condition and their doctor states in their restrictions that they need to be seen again in 6 months, it is not reasonable for management to require the carrier to get updated restrictions every month.

Management is working with occupational health to look over carriers' restrictions and they are not accepting some of them based on the wording of the note. For example, a medical note that states, "carrier x is under my care. For medical reasons, I recommend that he work no more than 8 hours per day and 5 days per week." Management most likely will not accept this note for three reasons.

1. The wording "under my care" does not indicate a recent visit, it only shows that the carrier has been to this clinic in the past.

2. The wording "I recommend" is just that, it is a recommendation not a restriction.

3. The note is open-ended, there is not a follow up date.

A better note and one that management must abide by looks like this, "carrier x was seen by me on February 1, 2023. For medical reasons, carrier x is restricted to 8 hrs. of work per day and 5 days per workweek. Follow up appointment with me in 3 months."

If management does not accept your medical documentation you may need to reach out to your doctor to re-write the note.

It is important that when you are on restrictions to abide by the restrictions and not exceed them. The responsibility to abide by the restrictions is the responsibility of the carrier. In most cases, management is not going to keep you to your doctor's ordered limits. Management, in most cases, would love to see exceed your restrictions. It is important to remember that the reason the doctor has put you on restrictions is to allow you time to heal and that is not going to happen unless you do what the doctor orders.

If management gives you more

than you can handle, please let them know this in the morning by telling them when they do the morning go around and by filling out a help slip. Call them in the afternoon to remind them that you were given too much work and you need to abide by your medical restrictions. At the end of the day, call them to let them know you will be bringing mail back in order to stick to your restrictions. Be polite, yet firm and do not exceed the hours that you are medically limited to.

It is sad when management looks at carriers suspiciously when they submit work restrictions. What is even more troubling is when other carriers look suspiciously at other carriers. We don't know where people are coming from and what issues they are dealing with physically and mentally so please do not judge others. Please wish them a speedy recovery and encourage them to abide by their doctors' orders. In doing so, we are standing in solidarity with them.

Director of Retirees Report

Branch 9 lost Ron Lawrence, a Wildcat Striker this past January. He was a 55 plus year NALC member and a warrior for Letter Carrier causes. Serving for decades as treasurer for PAL 9, Ron literally wrote the book on how to manage political fundraising. This organization has brought us many political allies in Congress like Betty McCullum and Angie Craig. He toughed it out through many battles culminating in the recent Postal Reform Act and would have loved to see the end to WEP— Windfall Elimination Provision which negatively affects our CSRS retirees. A Retiree of the Year in 2006, Ron will be missed.

Some members of Congress are playing games again refusing to pay the country's bills unless spending for the coming year is decreased. So, where might these cuts come from? Neither party is known for lowering the Defense Department budget. So, cuts are projected to be proposed from Social Security and Medicare. The **Republican Study Committee** proposed a budget for fiscal 2023 that would gradually increase the eligibility ages for Social Security and Medicare and change the Social Security benefit formula for people 54 and younger, while not changing it for people closer to receiving benefits. The noise since Biden's State of the Union address is "hands off Social Security and

Medicare." Since abolishing these programs has been a Republican goal since their inception, we shall see.

Another proposal is to strengthen Social Security with the Social Security Expansion Act which would:

 Extend the solvency of Social Security for 75 years by requiring the wealthiest American households to pay their fair share of taxes. This legislation would lift the \$147,000 a year cap and subject all income above \$250,000 to the Social Security payroll tax. Under this bill, over 93 percent of households would not see their taxes go up by one penny. Expand Social Security benefits across-the-board for current and new beneficiaries. Under this bill, Social Security benefits for current and existing recipients would be increased by \$200 a month. Increase Cost-Of-Living-Adjustments (COLAs). This bill would more accurately measure the spending patterns for seniors by adopting the Consumer Price Index for the Elderly (CPI-E). Older Americans, spend a disproportionate amount of their income on health care and prescription drugs and that would be reflected in the formula for calculating COLAs under this legislation.

The Stamp Out Hunger Food Drive

2023 Proposed By-Law Additions & Changes

ARTICLE VII BY-LAW COMMITTEE SECTION 2.

Current Language:

These By-Laws shall not be repealed, altered or amended except by a two thirds vote of the members present at voting. All proposed amendments must be presented in writing to the Recording Secretary no later than the February General Membership Meeting. Changes will be voted on at the regular April General Membership Meeting. A by-law may be brought up at any regular meeting if approved by two thirds (2/3) of the Stewards Board or upon written request of 225 of the members.

Proposed Language:

These By-Laws shall not be repealed, altered or amended except by a two thirds vote of the members present at voting. All proposed amendments must be presented in writing to the Recording Secretary no later than the February General Membership Meeting. Changes will be voted on at the regular April General Membership Meeting. A by-law may be brought up at any regular meeting if approved by two thirds (2/3) of the Stewards Board or upon written request of 45 of the members.

ARTICLE V RULES GOVERNING COMPENSATION OF DELEGATES SECTION 2.

Current Language:

Effective July 2004, (for future conventions) eligibility for payment of any delegate or alternate will include attendance at nine (9) out of twelve (12) General Membership Meetings of the preceding year for yearly conventions, and/or eighteen (18) out of twenty-four (24) **General Membership Meetings** of the preceding two (2) years prior to the biennial convention. Verification of attendance will be by meeting attendance book only. Any person unable to meet this eligibility requirement because he or she is incapacitated by a documented extended illness, or on family medical leave shall be exempted from the aforementioned criteria and will be entitled to delegate pay. No National officer receiving funds from the National is eligible for payment from the Branch; no State officer receiving funds from the State Association is eligible for payment from the Branch.

Proposed Language:

Effective July 2004, (for future conventions) eligibility for payment of any delegate or alternate will include attendance at nine (9) out of twelve (12) General Membership Meetings of the preceding year for yearly conventions, and/or eighteen (18) out of twenty-four (24) **General Membership Meetings** of the preceding two (2) years prior to the biennial convention. RALLY FOR STAFFING, SAFETY, AND SERVICE ON APRIL 2

Poor staffing levels and mandatory overtime have created a crisis at USPS. National contract negotiations between NALC and USPS began on February 22, 2023, and Letter Carriers need to fight for a contract that addresses the poor working conditions we face.

At the General Membership Meeting on February 28, 2023 a resolution passed calling for NALC Branch 9 to organize a press conference and rally on Sunday, April 2 at the downtown Minneapolis Post Office under the banner "Staffing, Safety, and Service - Letter Carriers Need a Raise".

As public sector workers our best weapon in contract negotiations is public opinion. The American public knows that there have been major delays in mail service in many communities, but they don't necessarily know why. They need to hear from Letter Carriers about the short staffing and poor working conditions at many stations.

The short staffing crisis has impacted every aspect of our job as Letter Carriers. From forcing us to take precious time away from our families and friends, and causing more and more on the job injuries, to worsening morale among Letter Carriers. Every day turns into a crisis with carriers being forced to work 10, 12 and even 14 hours.

A national contract that addresses working conditions, and pay is crucial. The only way to solve the staffing crisis at USPS is by making the Letter Carrier job a desirable job again.

Come out on Sunday, April 2 to rally for Staffing, Safety, and Service, and for a strong national contract. More details will come out and be made available at the March Steward Board Meeting and the March General Membership Meeting.





Dear Brothers and Sisters, We are writing to ask for your financial support to continue our work, protecting our right to

collective bargaining for pay and working conditions via our Political Action Committee, PAL 9. Our PAL 9 funds are used to engage and support the elected officials of Congress who are committed to empowering working people and sustaining the U.S. Postal Service.

We had a great victory when the Postal Reform Act was passed by Congress in bipartisan fashion and signed into law. This legislation removed the \$5.6 billion annual pre-funding mandate for retiree health benefits, gave us guaranteed 6-day delivery, and modified the Federal Employee Health Benefits Program.

This success does not remove the need to educate and support our friends in Congress. PAL 9 supports H.R. 82, the Social Security Fairness Act, which would eliminate the pension offset, allowing retirees who have earned two retirement pensions to receive both in full. H.R. 4268, would allow carriers who have worked in a temporary status, (Casual, TE or CCA), to "buy back" that time to apply to their Postal Service pension. This will provide an increased monthly payment upon retirement. For more information on these bills, go to NALC.org, under the Government Affairs heading.

As Congress continues to govern our workplace, we, as Letter Carriers, must be active and engage in politics at the local, state, and national level. We appreciate your support, which helps make this possible.
