The first official uniform regulated in 1868 — was blue gray with black trim. Since mail delivery in large cities had only begun five years prior in 1863, the uniform projected an air of legitimacy to those performing this vital government function.

Many new employees may not be aware of the Postal Service's history.

However, when they attend the carrier academy in Minneapolis, they learn about postal history when Minnehaha Station Letter Carrier and Branch 9 member Ben Noble steps up to the podium.

Noble teaches while donned in a vintage letter carrier uniform from the 1980's to help the organization's history to life.

"At the academy, I wear it as a special treat," Noble said. "I found some vintage things, and other carriers handed some stuff off to me."

Noble uses the uniform to highlight the importance of taking pride in the work letter carriers do. He goes on to talk about how he uses the skills from his past work experience to help him be a better carrier every day. He then states how a person's prior skill set can help them get where they want to go within the Postal Service.

I'm blessed to be able to contribute my skill set to the Post Office," he said. I absolutely love this job and the uniform helps me celebrate that."



PRESIDENT'S REPORT

Heat Safety

Here we are in the heart of the summer months. Most days in the summer are great for us letter carriers. We hear customers tell us, "sure is a nice day to have your job." And other comments that we never hear in the heart of winter. While they are correct, that doesn't mean that we don't need to be careful. Please take the heat safety talks that we hear so often seriously. There are a few things that we can do to ensure that we do not suffer from heat exhaustion or worse.

Stay hydrated. Hydration starts the day before and it involves drinking a lot of water and drinks with electrolytes like Gatorade or Powerade.

Take extra breaks. If you are driving an LLV or your vehicle does not have working air conditioning, get to a place that has air conditioning and cool down. If your manager questions you about the stationary event, let them know that it was because you needed a break from the heat.

Avoid alcohol and caffeine.
Both dehydrate you; This
doesn't mean that you
can't have your cup of
coffee in the morning,
just don't drink too much
coffee. Also, avoid
overdoing it on energy
drinks like Red Bull,

Rockstar, Celsius, etc.

Monitor your own health. Be aware of the signs of a possible heat related illness. Those signs could include dizziness, weakness, nausea, or confusion. If this is happening to you, then you will need to stop delivering the mail and call to get help. Sometimes it could be that you need to drink some water or take a break in a cooler environment before you can go on, but it could also be that you are feeling the effects of a heat related illness, and you cannot proceed with mail delivery. It is ok if you feel that you cannot continue to carry the mail. Your health and safety are more important than the mail!

Please be careful out there, there is only one you. We care about you and want you to go home safe every day.

<u>Protect Our Letter Carriers Act</u> (POLCA)(H.R. 7629)

This year at the State Fair we are going to educate fairgoers on the POLCA. We are going to tell them about the importance of the act and how, if it were passed would do a lot to protect letter carriers from crime. Fairgoers will be able to put their names and addresses on a postcard and we will mail the postcards to their members in

congress asking them to cosponsor this important legislation.

Since 2020, there have been more than 2,000 crimes committed against letter carriers on the job. Many of these attacks involve a gun or another weapon. Letter carrier robberies climbed to 643 last year, an increase of nearly 30 percent, and the number of robberies resulting in injuries doubled.

Exec. Vice President's Report

Hot months

August and September are still extremely hot months. I know we hear about heat a lot but it is very important to take precautions and protect ourselves from the weather. It is also very important to keep an eye out for each other. Many times, as carriers we overlook the warning signs with heat exhaustion. For example, it's really hot out but you think, it's only a couple of more blocks. I can get it done. I am guilty of this myself, countless times. Sometimes it takes an outside perspective to say hey you look hot, is everything ok? Just that little bit of care from a coworker could be enough to start the thinking process and take action. Remember to take the breaks needed to get to a cool place and stay hydrated.

Forcing and reporting curtailed mail

I am hearing many stations are forcing more lately as the existing staffing issues are combining with peak vacation season. Nobody likes to be forced to do anything they do not want to do. At the end of the day, management must try to get all the mail delivered which means they may have to force carriers off of the overtime list. For management to do this, they must follow the correct steps. If you have any questions about your management and if they are doing this process correctly or have a reason to believe that management is not following the pecking order, please report this to your steward.

Whenever I hear the word forcing, to me it raises the odds that mail will be curtailed. It has become clear that upper management wants to put a stop to anyone working over 12 hours.

This is a good thing, but like any action, there will be a reaction. In this case it's very likely that mail is being curtailed at the stations. Curtailed mail is any mail that was not delivered that day and must wait to be delivered the next day. This mail must be reported to management by filling out a PS Form 1571 (a curtailed mail slip). When you are not going to be able to deliver all the mail in the time allowed, ask for a PS form 1571(curtailed mail slip), fill out all the boxes and turn it into management.

Has this ever happened to you: Coming back to work after having a day off and it looks like you have a full case of mail already before you punch in, or trays of pulled down mail from the day before as if your route or parts of your route hadn't gone out for delivery? Or a hamper full of post that looks like it was from the day before? If you have, it's really important to make sure that gets reported correctly to management that it was undelivered. In turn, management will report that information to their superiors so upper management is aware that all the mail is not being delivered. It has come to my attention that maybe, just maybe, local management isn't reporting mail that is being curtailed. My guess would be that they do not want to be on another teleconference regarding this issue. If this is happening on a regular basis, then this is hurting you. It harms the carriers by not letting upper management know they need to staff better at your station. It harms the carriers by not getting an accurate mail count, so we get the proper route credit. It harms the customers that we serve every day because they

don't get their mail/packages. When you submit your PS Form 1571 to management, ask them to sign it and provide you with a copy as a receipt. This is how we can keep management accountable in this area.

Route inspections

The TIAREAP process has ended and route inspections are coming. TIAREAP was the process where management conducted the route inspection through the scanner. They are back to the old way of doing things for route inspections. Looking at the seniority roster, it is very likely that most carriers carrying mail in Branch 9 have not been thru these 6-day mail counts and inspections. But don't worry. If your station has been selected to go through route inspections, please let the Branch know so we can get information out to the members prior to the start of inspections. We do have a nice power point presentation that explains a lot of how the process works and can help carriers better understand what to expect with the mail counts and inspections. Please reach out to the Branch if you would like to get a copy of that power point.

Director of Retirees Report

HERE WE ARE AGAIN POLITICAL

In the coming months our union's focus will be mainly on politics. Our pleas for action to volunteer have to be constant, from writing letters and making phone calls to your legislators to staying informed on current Postal issues. To be followed with another important task. **VOTE!** We have to insure that the future of our jobs, wages, health insurance and retirement benefits are protected. This will only happen if the right people that support Postal issues are elected. Once we succeed with electing the supporters of our issues in Congress we have to constantly monitor and contact them with the current issues that affect us. I have heard members say I'm not voting as a sign of protest. Not voting is not a sign of protest but rather a sign of surrender!

WHAT DO I SAY?

Carriers need to understand that the future of the USPS, and our livelihoods are at stake. Our current problem is that most carriers aren't quite sure what to say and write when communicating with their representatives or senators. Some branches have provided their members with form letters that are basically "fill in the blank". These letters are easy to do but, they don't really convince your legislator that you're all that concerned or informed. A personalized letter is best because it actually requires someone to read it, not just count it. It will be more unique, and show that you, as its author, are informed and specifically concerned about specific issues as a voter and constituent. Bottom line, it's more real. It doesn't have to be lengthy, technical or worthy of a

prize from your grammar teacher. Whether it be hand written, typed, or an email, they pretty much count as the same thing.

Here are some tips for your letter:

Identify yourself, as a resident and registered voter in their District/State. This will help to drive home the message that you're one of the voters that voted for them during the election that put them in office. You will also want to tell them that you're a letter carrier with the USPS.

List your concerns, you don't have to be scientific or lengthy, just describe your situation and concerns. Refrain from broad generic statements like "Save the Post Office" but rather be specific. Our national web site "nalc.org" is constantly updated with current legislative issues as well as our own branch web site "branch9nalc.com". The best way to keep informed of current issues or actions needed to be taken by our members is to sign up for E-Activist with the NALC office.

Refer to the Bill Number, if available. Every bill has a number which identifies it in either the House (number starts with "H") or Senate (number starts with "S"). This will clarify your area of concern with the bill they'll eventually be voting on

Ask them to contact you, don't be expecting a phone call directly from your congressman/representative but you may receive a call or return letter/email from one of their staffers, acknowledging your letter or

email and telling you the representatives position (if they have one).

Follow Up, now if your actions and the action of others have earned a positive vote on your issues make sure to follow up with a thank you. Not only in a letter, but if by chance you meet them in person say thank you and ask them for their continued support.

The names and contact information for all legislators representing the State of Minnesota are listed in the pocket calendars the Branch hands out to every member yearly. The information is also listed on our website "branch9nalc.com" under the heading of Legislative.

We (as letter carriers) have a chance every day to make ourselves irreplaceable to our customers. Lastly I urge all members that have not done so to sign up for Letter Carrier Political Fund (LCPF), by giving \$5 a pay period and join our local PAL 9. For the members that have already joined a big *THANK YOU!*
