On May 11, letter carriers in virtually every community across the country shouldered the load by collecting food donations left by customers as part of the Letter Carriers' Stamp Out Hunger Food Drive. The food helps the hungry in those communities, with donations delivered by NALC members to local food banks.

Since NALC's first national food drive in 1993, active and retired letter carriers, with the help of volunteers, have collected a total of 1.9 billion pounds of food leading up to this year's drive.

"Letter carriers showed up again for their communities and helped ensure that the needs of the hungry are met in every city and town in the United States," NALC President Brian L. Renfroe said.

One in 8 Americans, including millions of children, senior citizens and veterans, are unsure where their next meal will come from. The May food drive helps to relieve shortages that food pantries experience in spring and summer after holiday donations have been depleted. And when summer arrives, most school meal programs are not available, so the need for food grows. The annual food drive wouldn't be possible without the support of our national partners: the USPS, the United Food and Commercial Workers International Union, the Rural Letter Carriers' Association.



# **Exec. Vice President's Report**

Hello Branch 9,

Heat

Summer is here and as we roll into it, we are faced with new challenges. Heat can create harsh obstacles while we as letter carriers are out delivering the mail. Dave Allmann, Branch 9s safety liaison, along with MPLS safety team have been visiting stations to go over the Heat Illness Prevention Program (HIPP). Heat can affect each person differently and even show differently in the same person from day to day. If you are experiencing any of the symptoms of heat stroke or heat exhaustion, it is extremely important to take it seriously and get to a cool place to recover. Follow the directions on the heat cards that management should have handed out to all carriers. If you have not received your card, let your steward know or reach out to the branch.

#### School's out for summer

Kids are out of school for the summer which means busier neighborhoods. Please take extra care looking out for kids playing in the street and running around the neighborhood. Also keep in mind that kids are home so they very likely will be the ones in charge of dogs while playing outside. Even if you have a great relationship with the dogs on your route, they may act differently when a child is added to the situation and be more protective. If you know a delivery has a dog or see a warning card, shake the gate or give them a whistle to see if they are out. A good rule of thumb is if the dog is out, don't deliver the mail. If the owner or kids are out playing, ask that they put the dog inside so you can complete the delivery.

#### **POLCA**

Over the last few months, I have been spreading the word about the Protect Our Letter Carriers Act. I have had many members ask me what we can do to get protection out on their route. Well, this is it. Around the country us letter carriers have held enough is enough rallies and it raised awareness to get this bill created, now its time to seal the deal. If this bill was passed into law, it would be a gigantic step toward keeping all letter carriers safe while out on their routes. Since 2020 we have had a 300 percent increase in violent crimes against letter carriers across the country. This bill would provide the 7 billion dollars that is needed to secure its infrastructure and it would strengthen sentencing for the crimes against letter carriers to be treated in the same manner as assaults on federal law enforcement officers. The POLCA is gaining support as on May 16th Sen Kristen Gillibrand (D-NY) and Sen Josh Hawley (R-MO) introduced POLCA in the Senate. This is a bipartisan, 1 issue bill. I encourage all our members, families, and friends to support this cause. For NALC members it is very easy (less than 5 minutes) to show your support. Just go to NALC.org and look for the Take Action link and it will take you through the quick steps.

Back in April we had our MDA Bowl A Thon and thanks to all of you it was a big success. In July the NALC is having a donation drive challenge for the branches across the country. It is time for the second Branch Challenge of 2024! From July 1 - July 31. NALC Branches are already

#### THE STRAIGHT SCOOP

I was honored to be selected by the NALC Executive Council to serve on the Article 10 evidentiary panel and by my panel colleagues Brother Brian Hellman and Sister Myra Warren to serve as the chairperson. Now that NALC has made our report available to the membership, I hope that members will read it carefully before making their judgements about the charges that were filed against Brian Renfroe. I say this because it is apparent that there remains considerable misinformation and misunderstanding about the Article 10 process, and how it played out. And in particular, the purpose and standing of an investigative report which has come to be dubbed the "Weir Report". In the scheme of Article 10, that report is meant to serve solely as an initial finding of facts, presented to the executive council for the purpose of determining whether charges have sufficient substance to be moved forward. Four of the original eight charges met that standard in the judgement of the council. Thus, pursuant to Article 10, our evidentiary panel was appointed to conduct hearings. We held six days of hearings at NALC headquarters in Wash DC. Both the charging party Brother Jackson, and the charged party, Brother Renfroe had ample opportunity to fully present their evidence and arguments, and to confront the others, in a format similar to arbitration, in our best effort to assure due process. After closing arguments, the panel spent numerous days deliberating and writing our report to the council with our findings, judgements and recommendations. Pursuant to the meaning and intent of Article 10, it was this report which the council chiefly relied upon in making it's decisions. But unfortunately, due to political agendas, naiveite or lack of information, the so called " Weir Report" continues to be bandied about like it is the holy grail on this issue. That is a disservice to the parties, the Article 10 process, and the NALC.

To be clear, the panel believes

that Brother Weir made a sincere effort. But some of what he reported as "facts" did not stand up when tested under evidentiary standards. Further, the report was rife with his personal opinions and judgements which respectfully, the panel felt went beyond the scope of his mission.

So, members interested in being more fully and accurately informed about the outcome of the charges should carefully read our panel's report. You will also see that the executive council did not follow all of our recommendations, which under the NALC Constitution, was their right.
